To which recipients will your data be communicated?

¿ What are your rights when you provide us with your data?

Anyone has the right to obtain confirmation on whether PRAFAMAR S.L. we are treating personal data that concerns you, or not.

Interested persons have the right to access their personal data, as well as to request the rectification of inaccurate data or, where appropriate, request its deletion when, among other reasons, the data is no longer necessary for the purposes for which they were collected.

In certain circumstances, the interested parties may request the limitation of the processing of their data, in in

which case we will only keep them for the exercise or defense of claims.

In certain circumstances and for reasons related to their particular situation, the interested parties may object to the processing of their data. PRAFAMAR S.L. will stop processing the data, except for legitimate and compelling reasons, or the exercise or defense of possible claims.

Likewise, in certain circumstances and when technically possible, the interested parties have the right to have their personal data transmitted directly to another controller at their request.
